Work Orders by Division

The Board reviewed and discussed the work orders in their respective divisions.

West Richland Ground Water

No new information to report.

Water Stargrass

Mr. Strifert has been coordinating with the Benton Conservation District on a grant through Ecology and the Conservation District Board. Preliminary indications are positive, with anticipated funding to cover the purchase of a tether boat for the harvester and an additional \$30,000 toward the operating costs. Mr. Strifert will keep the Board informed on the progress. The Conservation District will reimburse The District for the boat purchase, while The District will be responsible for its maintenance and winterization.

Sale of 10 E. Kennewick Ave

Mr. Strifert reported that an appraiser was selected. The advertisement will be placed after the appraisal has been finalized.

Rubicon Gates

Mr. Strifert has identified three locations for installation of the additional gates, including the corner of Washington and 27th, and two points along Lateral 2. There may be potential for one more gate, but the performance of these installations will be assessed before any further decisions are made.

AquaSystems 2000 Filtration

Mr. Strifert discussed the potential addition of three more AquaSystem screens in the canal. While the specifics do not need to be finalized at this time, the intent was to begin exploring the possibilities and open the conversation for further consideration.

NEW BUSINESS

Operations Report

Mr. Strifert provided an update on the field crew's efforts to catch up on work orders, noting that both Mr. Amend and Mr. Strifert have been assisting in the field to support progress. Additionally, Mr. Strifert shared the potential opportunity to apply for a grant through the Department of Ecology, contingent upon aligning our project needs with the grant's eligibility criteria. If selected, the project could be completed within this year. Mr. Strifert will keep the Board updated on the progress.

Water Right Procedure

It was agreed to keep the water rights procedure on the agenda, even if progress is minimal, to ensure continued attention and discussion. The Board reviewed the draft procedure for relinquishment.

EXECUTIVE SESSION

President Shawver moved the meeting into Executive session at 10:47 a.m., for 30 minutes, to discuss legal risks of current or proposed action and the performance of a public employee. Director Ayde asked about the Stargrass trash rake cleaner, Mr. Strifert advised that he is working on finding funding for the trash rake. Additionally, the grant for rebuilding the Wanawish Dam received additional funding and is progressing quickly.
