Department of Natural Resources Update

Shop Pole Building

Mr. Strifert reported on the status of the Shop Pole Building that we are still waiting for County's approval on the site plan and the engineered drawings from the contractor.

Tree Service Contract Bids

Mr. Strifert reviewed the Tree Service Contract Bids. The District received two bids:

Superior Tree Service, Inc. - \$238.00/hr. No bid bond included.
Boyd's Tree Service - \$346.00/hr.

Director Martin motioned to reject both bids. Director Ayde seconded the motion. Motion carried. Director Dickenson motioned to readvertise for the Tree Service contract. Director Martin seconded the motion. Motion carried.

Lateral #1 Siphon Pipe Slipline

Mr. Strifert provided an update on the Lateral One Siphon Pipe Slipline project. He expects the project to be completed next week.

Vehicle GPS

Mr. Strifert provided an overview of the GPS system and reported that the GPS has been installed on the most at-risk vehicles.

Rubicon Gate Grant Project - NTP

Mr. Strifert reported that we have received the notice to proceed for the four Rubicon Gates. Mr. Strifert announced that we also received notice that we were awarded for FY 2022, the Rubicon Gate Grant for the four additional gates.

Resolution 2023-1

Director Martin motioned to adopt Resolution 2023-1 for the condemnation of the Waldren Lateral Easement. Director Dickenson seconded the motion. Motion carried.

DIRECTOR DISCUSSION

President Shawver announced that Mr. Strifert's performance review is scheduled for the January 20th meeting. President Shawver reported that the Biden administration on Friday, December 30, 2022, issued a clean water rule that repeals Trump administration changes. The new rule defines which type of waterways will receive federal water quality protections under the 1972 Clean Water Act. The revised rule is based on definitions that were in place before 2015.


