CALL TO ORDER

PUBLIC COMMENT

The patron shared concerns about water flow issues related to the layout of the irrigation line near her property. She mentioned challenges with getting water when nearby systems are activated and suggested that a more direct setup might help improve efficiency. She also expressed appreciation for the support and assistance from the service team. Mr. Strifert explained that some adjustments were made that should help with the problem including a valve that was not turned on during the water start-up process.

Water Stargrass-ILA Benton Conservation District

Mr. Strifert reported that the initial draft of the interlocal agreement was forwarded to legal counsel, Mr. Sperline. Following review and incorporation of comments, the revised draft was returned to the Benton Conservation District. A response is expected in the next week.

Aqua Systems 2000 Filtration

The Weldy location is being explored as a potential site for a new AquaSystem filtration system. A site visit with the company representative is being arranged to discuss design options that would minimize canal modifications.

Water Right Procedure

No new options were reported at this time.

Ziply Fiber Right-of-Way Permit

Mr. Strifert reviewed the permit application #MC-25001. Director Thackham motioned to approve Permit #MC-25001, Director Dickenson seconded the motion. Motion Carried.

NEW BUSINESS

Operations Report

Mr. Strifert provided the following updates:

The first canal treatment for stargrass and aquatic weeds is scheduled for next Wednesday. Drone flights will be coordinated with Benton Conservation District to record footage before and after treatment to show effectiveness. This footage will be shared with the Water Stargrass Coalition.

There have been some challenges getting water to the headgates due to a temporary lull in water delivery pulses. Current water delivery stands at approximately 95% of users; efforts are being made to maintain service to the remaining users, primarily on gravity lines by raising water levels in the canal.

A voluntary watering schedule will be implemented and posted on the District's website, encouraging residents to water on even-numbered days if their address ends in an even number, and on odd-numbered days for odd-numbered addresses.

Meetings of July 4th & 18th

Director Thackham motioned to change the July 4th meeting to June 27th. Director Dickenson seconded the motion. Motion carried. The July 18th meeting will focus on training.

Kennewick Trails & Pathways Plan

Mr. Strifert recently met with City of Kennewick representatives to discuss potential pathway projects along our canal right of way. Proposed plans involve a combination of paved and gravel walking paths. The project remains in the early planning stages and is not expected to advance for another year or two.

CID/Badger Mountain Irrigation District Right-of-Way

Moved into Executive session.

CID Right-of-Way Policy & Permits

Mr. Strifert presented the policy revisions to the Board for review. Director Thackham motioned to approve the revisions. Director Martin seconded the motion. Motion carried.

YBJB Tour

The Board discussed and confirmed attendance for the upcoming YBJB tour.

President Shawver moved the meeting into Executive session at 11:04 a.m., for 30 minutes, to discuss legal risks of current or proposed action. The meeting was moved to open session at 11:34 a.m.
